This means that if you want to then work in a "regulated" environment within a Bank, Hedge Fund or other Financial Firm you will have the necessary qualifications that the regulator requires. The UK regulator is the Financial Conduct Authority (FCA).

The Practical element of this course is executed in conjunction with The Academy of Trading, which is part of Universal Private Equity. This is the part of the course where you will learn in depth from experts exactly what you need to do to consistently trade the financial markets **profitably**.

After this there will be a 3-6 month period where you will actually trade so that we can monitor you to ensure that you have assimilated all of the lessons contained within the course. ## HOW IS THE QUALIFICATION STRUCTURED?

This is a unique course which is extremely highly regarded within the industry. It is fundamentally divided into two parts, the first part being the **Academic** element, and the second part being the **Practical** element.

## THE ACADEMIC ELEMENT

This element has to be completed through the CISI (The Chartered Institute for Securities & Investment) or you should already hold an equivalent qualification through an alternative professional body. Through the CISI the Academic element is comprised of the "Capital Markets Programme" which essentially is a modular exam structure made up of at least two units. One regulatory unit and one technical unit.

## The Regulatory Unit

This is made up from a choice of either "UK Financial Regulation" or if you are based outside of the UK the local regulatory unit for your jurisdiction.

## The Technical Unit

This is made up from a choice of either

- Securities/Global Securities
- Derivatives
- Financial Derivatives/Global Financial Derivatives.

## **Integrity Test**

In addition to the above 2 units you have to also pass the CISI's "Integrity Matters" Test. This is an online integrity test designed to highlight ethical dilemmas which you may face at work. This is applicable to those candidates who are based in the UK, Ireland, Europe and the USA. You must pass the "Integrity Matters" test as a pre-requisite to sitting the rest of the Academic element.



## HOW THE ACADEMIC MODULES ARE ASSESSED

In order to complete the "Regulatory" unit you required to sit and pass a one hour 30 minute multiple choice question exam. The exam length for technical units can be up to two hours and are also multiple choice.

All exams can be taken at one of the CISI's Computer Based Testing (CBT) centres. You can visit cisi.org/cbt to find your nearest venue.

Once you have passed these academic exams you can be secure in the knowledge that these qualifications will hold you in good stead as they are recognised and accepted worldwide. So if you want to then work in a "regulated" environment within a Bank, Hedge Fund or other Financial Firm you will have achieved the minimum necessary qualifications that the regulator requires. The UK regulator is the Financial Conduct Authority (FCA).

## THE PRACTICAL ELEMENT

This element has to be completed through the Academy of Trading (which is part of Universal Private Equity Ltd). It is comprised of three elements which are divided into separate segments but essentially it is broken down into


